The Nordic Academic Network for Competition Law was organized on April 15.-16. in Helsinki by the Department of Accounting and Business Law, Aalto University.

We had presentations of the doctoral researcher on Monday the 15 April. Presentations of the doctoral researcher were followed by comments of a professor level discussant, who had received the presentation in advance.

The second day, Tuesday April 16, consisted of presentations of senior researchers. On the second day we had also the Nordic roundtable on national developments.

Based on the feedback given by the ca. 30 participants from various Nordic countries the event was a great success.
